CHANGES MADE BY THIS TARIFF

- 1 – TransPasses will no longer be valid on Regional Rail for travel between Center City Stations on non-holiday weekdays.
- 2 – Upon implementation of New Payment Technology, TransPasses will no longer be valid on Regional Rail for travel on the Airport Line to/from the Airport and Center City Stations on non-holiday weekdays.
- 3 – Weekly Cross County pass has been established.
- 4 – Quantity Purchase prices have been changed to reflect the fare increases.
- 5 - New Rules and Regulations have been established to go into effect and supersede the current Rules and Regulations when the transition to New Payment Technology has been completed.

During the effective period of this Tariff, SEPTA will be instituting a New Payment Technology. The Fares, Rules and Regulations in this Tariff will overlap the transition period to this Technology, so it is necessary to establish two sets of rules to accommodate each of the methods. During the transition period there will come a time when both technologies will be used simultaneously, in which case, both sets of Fares, Rules and Regulations would be in effect and would apply to the specific technology in use at the time. The first set of Fares, Rules and Regulations will cover the period prior to the establishment of New Payment Technology, while the second set will supersede the first when New Payment Technology goes into effect.

BEFORE NEW PAYMENT TECHNOLOGY

(A) REGIONAL RAIL DIVISION/TRANSIT DIVISION JOINT FARE

- 1) A valid Weekly or Monthly TrailPass will be accepted for travel on any regular service transit route vehicle operated by either City Transit Division or Suburban Transit Division. Additional fees could be required on Special Fare Routes. See City Transit Division Tariff No. 1 and Suburban Transit Division Tariff No.155 for details on Special Fare Routes. TrailPasses are governed by the Regional Rail Tariff No. 154.
- 2) A valid Monthly or Weekly TransPass will be accepted for travel on any regularly scheduled Regional Rail train at all times on the Airport Line to/from the Airport and stations designated as Center City Philadelphia in Tariff No. 154.
- 3) A valid Weekly or Monthly Cross County Pass will be accepted for travel in any direction involving any number of Fare Zones on any regularly scheduled Regional Rail train at any time within suburban counties or stations not identified as Center City Philadelphia. For travel to, from or via Center City Philadelphia on a non-holiday weekday, Zone 1 fares will apply in addition to the pass. See Regional Rail Tariff No. 154 for Zone 1 Fares. The Cross County Pass is governed by Suburban Transit Division Tariff No. 155.
- 4) A valid Weekly or Monthly TransPass, Cross-County Pass or TrailPass has "Anywhere" status on Saturdays, Sundays and major holidays and is valid for unrestricted travel anywhere on the SEPTA system on any scheduled transit (bus, trolley, subway-elevated train) route or on any Regional Rail train without payment of additional fares or zone charges. Holidays are defined in the current supplements of the applicable operating Tariffs Nos. 1, 154, and 155.

(B) CITY TRANSIT DIVISION/SUBURBAN TRANSIT DIVISION JOINT FARES

- 1) A valid Weekly or Monthly TransPass will be accepted for travel on any regular service route operated by the Suburban Transit Division. Additional fees are

required on special fare routes. See Suburban Transit Division Tariff No. 155 for special fare routes. TransPasses are governed by City Transit Division Tariff No. 1.

- 2) A valid Weekly or Monthly Cross County Pass will be accepted for travel on any regular service transit route vehicle operated by either the City Transit Division or Suburban Transit Division within suburban counties only. Cross County Passes are governed by Suburban Transit Division Tariff No. 155.
- 3) A valid Weekly or Monthly Cross County Pass plus an additional zone fee of \$.50 will be accepted for travel on any City Transit Division or Suburban Transit Division regular service route within the City of Philadelphia. The Cross County Pass is not valid for travel on Route 78. Additional fees may be required on Special Fare Routes. See Suburban Transit Division Tariff No. 155 for special fare routes.
- 4) A valid Weekly or Monthly TransPass, Cross-County Pass or TrailPass has "Anywhere" status on Saturdays, Sundays and major holidays and is valid for unrestricted travel anywhere on the SEPTA system on any scheduled transit (bus, trolley, subway-elevated train) route or on any Regional Rail train without payment of additional fares or zone charges. Holidays are defined in the current supplements of the applicable operating Tariffs Nos. 1, 154, and 155.

(C) **CONVENIENCE PASS**

A CONVENIENCE PASS is valid for a single day's travel of up to eight (8) one-way trips in either direction on any scheduled transit (bus, trolley, subway-elevated train) route. The CONVENIENCE PASS is available for Eight Dollars (\$8.00). It will be valid during the calendar day designated by the date punched at the time of the first use and until 2:00 AM of the following day. Not valid for travel on Route 78.

(D) **INDIVIDUAL INDEPENDENCE PASS**

An INDIVIDUAL INDEPENDENCE PASS is valid for a single day's travel for one individual for unlimited trips in either direction on any scheduled transit (bus, trolley, sub-elevated train) route or on any Regional Rail train scheduled to arrive in Center City stations after 9:30 AM on weekdays and on all Regional Rail trains on Saturday, Sunday and holidays. The INDIVIDUAL INDEPENDENCE PASS is available for Twelve Dollars (\$12.00). It will be valid during the calendar day shown on pass until 2:00 AM of the following day. An additional \$5.00 surcharge will be applied for travel on each Regional Rail trip to or from the State of New Jersey. Not valid for travel on Route 78 before 9:30 am on weekdays.

(E) FAMILY INDEPENDENCE PASS

A FAMILY INDEPENDENCE PASS is valid for a single day's travel for five individuals where at least one and not more than two is at least eighteen years of age for unlimited trips in either direction on any scheduled transit (bus, trolley, sub-elevated train) route or on any Regional Rail train scheduled to arrive in Center City stations after 9:30 AM on weekdays and on all Regional Rail trains on Saturday, Sunday and holidays. The FAMILY INDEPENDENCE PASS will be available for Twenty-Nine Dollars (\$29.00). It will be valid during the calendar day shown on pass until 2:00 AM of the following day. An additional \$15.00 surcharge will be applied for travel on each Regional Rail trip to or from the State of New Jersey. Not valid for travel on Route 78 before 9:30 on weekdays.

(F) QUANTITY PURCHASES

- 1) Monthly and Weekly Passes may be sold in quantity to qualifying employers or organizations at incentive prices per the following schedule. To qualify for incentive prices, which are approximately 95% of the regular single purchase price, employers or organizations must be registered with SEPTA as a participating employer or organization.
 - a) Orders for all passes must be placed with SEPTA well in advance of start of the week or month for which passes are valid. (Cut-off date to be determined by SEPTA.)
 - b) Payment for all passes must be made to SEPTA by employer or organization in advance of receipt of passes by employer or organization.
 - c) Minimum order for Monthly passes is fifty (50) passes per month. The minimum order for Weekly passes is fifty (50) passes per week.
 - d) In order to participate in the Corporate Pass Program (COMPASS) the organization must, at minimum, match the 5% discount offered by SEPTA to its employees or members. A greater discount may be provided by qualifying employees or organizations, without limitation.

- 2) Cost to employers or organizations participating in the Quantity Purchase Price Program will be as follows:

- 3) Elementary and secondary schools (Grades K-12) and school districts may participate in the program for the purchase of tokens to be used by school students for educational travel purposes.
- a) The minimum purchase to qualify for the discount is 100 ten-packs (1,000 tokens).
 - b) Orders and payment must be made to SEPTA in advance of receipt of tokens by school or school district.

- c) SEPTA will offer a 5% discount for student token orders provided the school or school district offers a minimum 5% additional discount to students through direct subsidy.
- 4) SEPTA reserves the right to enter into agreements with organizations regarding quantity sale of pre-purchased fare instruments. Conditions and rates will be established by SEPTA and may be revised from time to time. The quantity discount may not exceed twenty percent (20%) of the regular single purchase price.

NEW PAYMENT TECHNOLOGY

(G) REGIONAL RAIL DIVISION/TRANSIT DIVISION JOINT FARE

- 1) A valid SEPTA Media Weekly or Monthly TrailPass will be accepted for travel on any regular service transit route vehicle operated by either City Transit Division or Suburban Transit Division. Additional fees could be required on Special Fare Routes. See City Transit Division Tariff No. 1 and Suburban Transit Division Tariff No.155 for details on Special Fare Routes. SEPTA Media TrailPasses are governed by the Regional Rail Tariff No. 154.
- 2) A valid SEPTA Media Weekly or Monthly Cross County Pass will be accepted for travel in any direction involving any number of Fare Zones on any regularly scheduled Regional Rail train at any time within suburban counties or stations not identified as Center City Philadelphia. For travel to, from or via Center City Philadelphia on a non-holiday weekday, Zone 1 fares will apply in addition to the pass. See Regional Rail Tariff No. 154 for Zone 1 Fares. SEPTA Media Cross County Passes are governed by Suburban Transit Division Tariff No. 155.
- 3) A valid SEPTA Media Weekly or Monthly TransPass, Cross-County Pass or TrailPass has "Anywhere" status on Saturdays, Sundays and major holidays and is valid for unrestricted travel anywhere on the SEPTA system on any scheduled transit (bus, trolley, subway-elevated train) route or on any Regional Rail train without payment of additional fares or zone charges. Holidays are defined in the current supplements of the applicable operating Tariffs Nos. 1, 154, and 155.

(H) CITY TRANSIT DIVISION/SUBURBAN TRANSIT DIVISION JOINT FARES

- 1) A valid SEPTA Media Weekly or Monthly TransPass will be accepted for travel on any regular service route operated by the Suburban Transit Division.

Additional fees are required on special fare routes. See Suburban Transit Division Tariff No. 155 for special fare routes. SEPTA Media TransPasses are governed by City Transit Division Tariff No. 1.

- 2) A valid SEPTA Media Weekly or Monthly Cross County Pass will be accepted for travel on any regular service transit route vehicle operated by either the City Transit Division or Suburban Transit Division within suburban counties only. SEPTA Media Cross County Passes are governed by Suburban Transit Division Tariff No. 155.
- 3) A valid SEPTA Media Weekly or Monthly Cross County Pass plus an additional zone fee of \$.50 will be accepted for travel on any City Transit Division or Suburban Transit Division regular service route within the City of Philadelphia. The SEPTA Media Cross County Pass is not valid for travel on Route 78. Additional fees may be required on Special Fare Routes. See Suburban Transit Division Tariff No. 155 for special fare routes.
- 4) A valid SEPTA Media Weekly or Monthly TransPass, Cross-County Pass or TrailPass has "Anywhere" status on Saturdays, Sundays and major holidays and is valid for unrestricted travel anywhere on the SEPTA system on any scheduled transit (bus, trolley, subway-elevated train) route or on any Regional Rail train without payment of additional fares or zone charges. Holidays are defined in the current supplements of the applicable operating Tariffs Nos. 1, 154, and 155.

(I) SEPTA MEDIA CONVENIENCE PASS

A SEPTA MEDIA CONVENIENCE PASS is valid for a single day's travel of up to eight (8) one-way trips in either direction on any scheduled transit (bus, trolley, subway-elevated train) route. The SEPTA MEDIA CONVENIENCE PASS is available for Eight Dollars (\$8.00). It will be valid during the calendar day registered at time of first use until 2:00 AM of the following day. Not valid for travel on Route 78.

(J) SEPTA MEDIA INDIVIDUAL INDEPENDENCE PASS

A SEPTA MEDIA INDIVIDUAL INDEPENDENCE PASS is valid for a single day's travel for one individual for unlimited trips in either direction on any scheduled transit (bus, trolley, sub-elevated train) route or on any Regional Rail train scheduled to arrive in Center City stations after 9:30 AM on weekdays and on all Regional Rail trains on Saturday, Sunday and holidays. The SEPTA MEDIA INDIVIDUAL INDEPENDENCE PASS is available for Twelve Dollars (\$12.00). It will be valid during the calendar day shown registered at time of first use until 2:00 AM of the following day. An additional \$5.00 surcharge will be applied for travel on each Regional Rail trip to or from the State of New Jersey. Not valid for travel on Route 78 before 9:30 am on weekdays.

(K) SEPTA MEDIA FAMILY INDEPENDENCE PASS

A SEPTA MEDIA FAMILY INDEPENDENCE PASS is valid for a single day's travel for five individuals where at least one and not more than two is at least eighteen years of age for unlimited trips in either direction on any scheduled transit (bus, trolley, sub-elevated train) route or on any Regional Rail train scheduled to arrive in Center City stations after 9:30 AM on weekdays and on all Regional Rail trains on Saturday, Sunday and holidays. The SEPTA MEDIA FAMILY INDEPENDENCE PASS will be available for Twenty-Nine Dollars (\$29.00). It will be valid during the calendar day registered at time of first use until 2:00 AM of the following day. An additional \$15.00 surcharge will be applied for travel on each Regional Rail trip to or from the State of New Jersey. Not valid for travel on Route 78 before 9:30 on weekdays.

(L) QUANTITY PURCHASES

- 1) Monthly and Weekly Passes may be sold in quantity to qualifying employers or organizations at incentive prices per the following schedule. To qualify for incentive prices, which are approximately 95% of the regular single purchase price, employers or organizations must be registered with SEPTA as a participating employer or organization.
 - a) Orders for all passes must be placed with SEPTA well in advance of start of the week or month for which passes are valid. (Cut-off date to be determined by SEPTA.)
 - b) Payment for all passes must be made to SEPTA by employer or organization in advance of receipt of passes by employer or organization.
 - c) Minimum order for Monthly passes is fifty (50) passes per month. The minimum order for Weekly passes is fifty (50) passes per week.
 - e) In order to participate in the Corporate Pass Program (COMPASS) the organization must, at minimum, match the 5% discount offered by SEPTA to its employees or members. A greater discount may be provided by qualifying employees or organizations, without limitation.
