**CHANGES MADE BY THIS TARIFF**

**BASE ROUTE ADDED:**

Beginning at the intersection of Bethlehem Pike & County Line Road located in Hilltown Township, thence via Bethlehem Pike and Souderton Road (PA Route 113) to the intersection of Souderton Road, Broad Street and County Line Road; to be operated in both directions.

**BASE ROUTE DISCONTINUED:**

Beginning at the intersection of Bethlehem Pike & County Line Road located in Hilltown Township, thence via County Line Road to the intersection of Souderton Road, Broad Street and County Line Road; to be operated in both directions.

**TURNBACK ROUTE DISCONTINUED:**

Beginning at the intersection of Main & Green Streets located in the Borough of Lansdale, thence via Green Street, private property of Lansdale Borough Parking Lot and Green Street to the intersection of Green & Main Streets.

**ROUTE 132 – TELFORD TO MONTGOMERY MALL**

**BASE ROUTE:**

**Northbound:**

Beginning on private property of Montgomery Mall located in the Township of Montgomery, thence via North Wales Road, Horsham Road, Cowpath Road, Broad Street, Main Street, Welsh Road, Forty Foot Road, private property of Hatfield Pointe, Forty Foot Road, Broad Street, Market Street, Union Street, Unionville Pike, Bethlehem Pike, Souderton Road (PA Route 113), Broad Street, Main Street, Reliance Road, Washington Street, Church Road and Hamilton Street to private property of Landis Market located in the Township of West Rockhill.

**Southbound:**

Beginning on private property of Landis Market located in the Township of West Rockhill, thence via Hamilton Street, Church Road, Washington Street, Reliance Road, Main Street, Broad Street, Souderton Road (PA Route 113), Bethlehem Pike, Unionville Pike, Union Street, Market Street, Broad Street, Forty Foot Road, private property of Hatfield Pointe, Welsh Road, Main Street, Broad Street, Cowpath Road, Horsham Road and North Wales Road to private property of Montgomery Mall located in the Township of Montgomery.

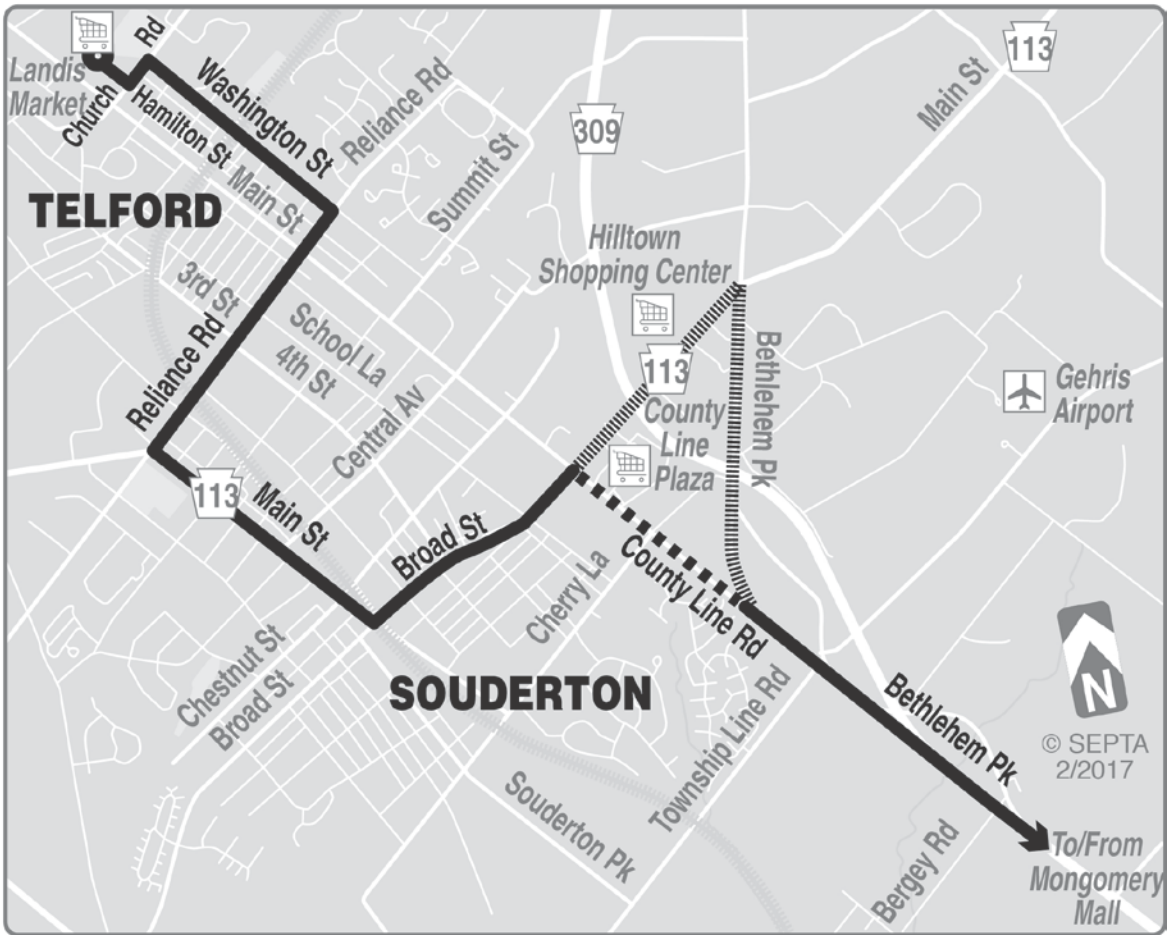
**EXTENSION (to be operated as required):**

Beginning at the intersection of Church Road & Washington Street located in the Borough of Telford, thence via Church Street, State Road (PA Route 152), Bethlehem Pike, Main Street, Walnut Street, 4<sup>th</sup> Street, Arthur Avenue, 5<sup>th</sup> Street, and Hillendale Road to private property of the Perkasio campus of Bucks County Community College located in the Borough of Perkasio; returning via Hillendale Road, 5<sup>th</sup> Street, Arthur Avenue, 4<sup>th</sup> Street, Walnut Street, Temple Avenue, Main Street, Bethlehem Pike, State Road (PA Route 152) and Church Road to the intersection of Church Road & Washington Street.
