CHANGES MADE BY THIS TARIFF:

BASE ROUTE ADDED

Beginning at the intersection of Lancaster Avenue (U.S. Route 30) & Morehall Road (PA Route 29), thence via Morehall Road, Brennan Boulevard (formerly Wyeth Drive), private property of Uptown Worthington, Matthews Road and Morehall Road, to the intersection of Lancaster Avenue & Morehall Road; to be operated in either direction.

ALTERNATE ROUTES DISCONTINUED:

Beginning at the intersection of Lancaster Avenue (U.S. Route 30) & Morehall Road (PA Route 29), thence via Morehall Road, Brennan Boulevard (formerly Wyeth Drive), private property of Uptown Worthington, Matthews Road and Morehall Road, to the intersection of Lancaster Avenue & Morehall Road; to be operated in either direction.

ROUTE 204 – EAGLEVIEW TO PAOLI STATION

BASE ROUTE

Westbound:

Beginning on private property of Paoli Regional Rail Station, located in the Township of Tredyffrin, thence via Paoli Plaza Drive, Greenwood Avenue, Lancaster Avenue (U.S. Route 30), Morehall Road (PA Route 29), Brennan Boulevard, private property of Uptown Worthington, Matthews Road, Morehall Road, Lancaster Avenue, Lincoln Highway (U.S. Route 30 Business), private property of Exton Square Mall, Swedesford Road, Pottstown Pike (PA Route 100), Gordon Drive, Pickering Way, Welsh Pool Road, Gordon Drive, Uwchlan Avenue (PA Route 113), Eagleview Boulevard and Constitution Drive to the cul-de-sac located along Constitution Drive, located in the Township of Uwchlan.

Eastbound:

Beginning along Constitution Drive and the cul-de-sac located along Constitution Drive, located in the Township of Uwchlan, thence via Constitution Drive, Eagleview Boulevard, Uwchlan Avenue (PA Route 113), Gordon Drive, Welsh Pool Road, Pickering Way, Gordon Drive, Pottstown Pike (PA Route 100), Swedesford Road, private property of Exton Square Mall, Lincoln Highway (U.S. Route 30 Business), Lancaster Avenue (U.S. Route 30), Morehall Road (PA Route 29), Brennan Boulevard, private property of Uptown Worthington, Matthews Road, Morehall Road, Lancaster Avenue and private property of Paoli Regional Rail Station, located in the Township of Tredyffrin.

ALTERNATE ROUTES (to be operated as required):

1. Beginning at the intersection of Lincoln Highway (U.S. Route 30 Business) and Springdale Drive, located in the Township of West Whiteland, thence via Springdale Drive and Ship Road to the intersection of Ship Road & Lincoln Highway; returning via Belden Boulevard and Springdale Drive to the intersection of Springdale Drive & Lincoln Highway.
2. Beginning at the intersection of Pottstown Pike (PA Route 100) & Gordon Drive, located in the Township of Uwchlan, thence via Pottstown Pike, and Sheree Boulevard to the intersection of Sheree Boulevard & Eagleview Boulevard; to be operated in either direction.
3. Beginning at the intersection of Gordon Drive & Pickering Way, located in the Township of Uwchlan, thence via Gordon Drive to the intersection of Gordon Drive & Welsh Pool Road; to be operated in either direction.

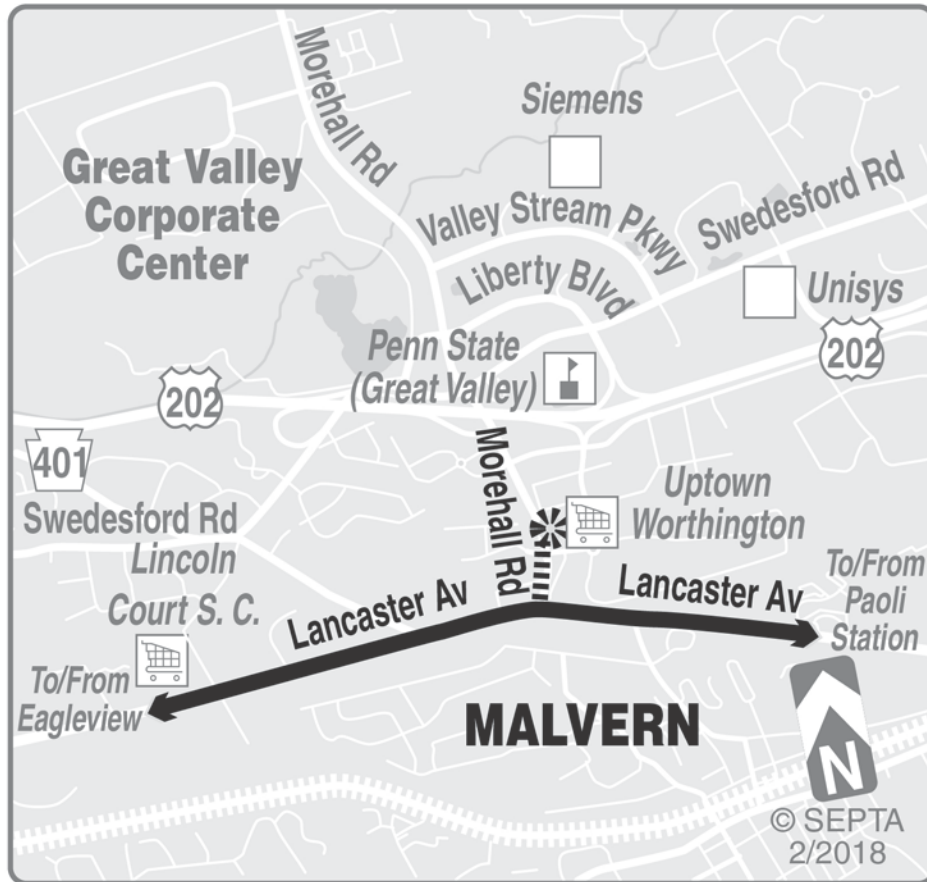
TURNBACK ROUTE (to be operated as required)

Beginning at the intersection of Pottstown Pike & Worthington Road, located in the Township of Uwchlan, thence via Worthington Road jug handle and Worthington Road to the intersection of Worthington Road & Pottstown Pike.
